

ONIX for Books codelists Issue 27

This is the consolidated list of additions and updates for Issue 27 of the ONIX for Books codelists. This list was circulated for comment to the national groups, and ratified by the International Steering Committee during its meeting at the Frankfurt Book Fair.

All ONIX users should note that this is the last issue of the ONIX codelists prior to 'sunset' of ONIX version 2.1 at the end of 2014. From the beginning of 2015, ONIX 2.1 will no longer be fully supported by EDItEUR and will be termed a 'legacy format'. This also applies to the matching Supply Update message. Three years prior notice of this sunsetting of support was given by EDItEUR and the ONIX International Steering Committee, and all users are strongly advised to migrate to ONIX 3.0 which will remain fully supported for the foreseeable future.

At sunset, documentation and various XML tools for version 2.1 will be withdrawn. However, certain codelists that are unique to 2.1 (for example codelists 7 and 78) will continue to be included in the downloadable codelist files, and will be updated as normal until the end of 2015.

Codelists Issue 27 Additions and Changes

Within the tables, additions are in red, changes and clarifications in blue and unchanged text is in black.

List 7 – Product form (ONIX 2.1 only)

Code	Label	Note
XM	Boxed pack	A quantity pack with its own product code, for trade supply only: the retail items it contains are intended for sale individually – see also WX. For products or product bundles supplied boxed individually for retail sale, use the Product Form code of the contents plus code 09 from List 80.

Like code XL, except that the trade pack (not the retail items within the pack) is boxed or in a carton.

14	E-book Short	'Short' e-book (sometimes also called a 'single'), typically containing a
		single short story, an essay or piece of long-form journalism.

There is a need to describe products judged (by the publisher) to be 'shorts' or 'singles'. This is generally a *marketing* distinction without a single clear definition, and it can affect the way a product is promoted and merchandised.

List 96 – Currency code (ONIX 2.1 and ONIX 3.0)

The list below indicates the conventional number of decimal places to use when quoting prices in each currency, taken mostly from ISO 4217 and the Unicode Common Locale Data Repository (CLDR). It varies from ISO 4217 and CLDR where they indicate the use of 2 or 3 decimal places but in practice the official subunit is of very low or negligible value and only whole units are used for book prices (for example, India, where officially 1 Rupee = 100 paise but book prices are always whole numbers of Rupees).

For most currencies, convention suggests two decimal places (eg 100 cents = 1 US Dollar), and you should assume two decimal places unless the codelist indicates otherwise. A handful of currencies use three decimal places (eg 1000 fils = 1 Jordanian Dinar), and List 96 indicates this using '(3)'. About 50 currencies are conventionally quoted as integers without any decimal places (eg Japanese Yen, Korean Won). For these currencies, either there are no subunits, or the previous subunits (eg the sen and jeon for the Yen and Won) are no longer in practical use, and this is indicated using '(0)'.

List 148 – Collection type (ONIX 3.0 only)

11	Collection éditoriale	The collection is a bibliographic collection defined and identified by a publisher, either on the product itself or in product information supplied by the publisher, where the books in the collection have no specific order, shared subject, narrative, style or shared authorship, and are grouped by the publisher largely for marketing purposes. The collection has many of the characteristics of an imprint or marque. Used only in French book publishing, to distinguish between 'série' (using the normal code 10) and 'collection' (code 11), and where the collection éditoriale is not an imprint.

This code is specifically for use in the French book trade, where such collections can comprise many tens or hundreds of individual books. The meaning of *collection éditoriale* is intermediate between that of 'series' and 'imprint'. Note that where a normal collection (code 10) or imprint name applies, they should be used in preference.

In French usage, a *série* should be treated as a normal code 10 collection. A *collection éditoriale* is conceptually 'larger' than a *série*, and may have *sous-collections*, *séries* and *sous-séries* nested inside it. Conversely, a *série* may not have a *collection éditoriale* nested inside.
