

## **ONIX for Books codelists Issue 51**

This is the consolidated list of agreed additions and updates for Issue 51 of the ONIX for Books codelists, as circulated to the ONIX national groups for comments and then ratified by the ONIX International Steering Committee at its October 2020 meeting.

This issue includes a number of additions and revisions to provide further details of library pricing, limits on POD manufacture, hazard warnings, new product forms and a method to differentiate different types of cards (cards for educational use, recreation, greetings and so on).

### List 59 – Price type qualifier

Note the difference between the Introductory price and the reservation order price – the latter does not apply after publication, whereas the introductory price may do so, and only the reservation order price includes a guarantee of delivery prior to publication.

Note the clarification to the existing XJ code. This was previously implied but not stated, and the clarification and introduction of the new XO code should make metadata describing spinner products less ambiguous.

Many of the modifications above are simple clarifications, *eg* of the types of disc used by each games console (and therefore the Product Form codes from List 150 that the relevant List 175 codes can be combined with). D317 is deprecated because it inadvertently duplicates code D313.

This clarification is to emphasise the default *dateformat* for event occurrence dates differs from that of most other <Date> elements in ONIX.
